trip along with twenty-nine other chorus managers, representing most of the choruses that will be competing there next summer. The purpose of our trip was to tour the hotels and contest venue and warm-up areas out there and get the "lay of the land."

There are 31 choruses that will be Portland. The Society made housing draw prior to our

Most of the hotels have plenty of doubles, two beds in one room, which could end up being pretty economical if you wanted to share a room. In two days we toured twelve hotels, the contest venue the Rose Garden, and the Convention Center, which is attached to the Rose Garden. It was a busy but necessary two day junket to the Great Northwest.

At the end of the day at our wrap-up meeting a chorus contest singing order draw was held. We will sing 23rd,

Central Standard will sing 22nd, and AOH is 17th. Fremont will sing 13th and *Hilltop* contests in 24th spot right after us. Should be a great contest and the second half will be loaded.

As for the hotel choices, we have no clue where we will end up because of our placement in the draw. Pricing varied greatly for \$119 to Embassy Suites at \$179 (includes made-to-order daily breakfast and an evening reception

> with heavy snacks, beer, wine and m i x e d drinks). Т h e average hotel cost approximately \$140-\$150 a night.

All hotels are located within two blocks of the MAX, Portland's light rail system that is free to all attendees within the downtown area.

Vince will be having a signup soon so please be planning to let us know if you would want a King Room, or a Double. Your answer is not binding in any way, but merely gives us an idea of your most likely intentions. In an earlier time, Frazier sang in two or three short-lived quartets in the Wichita area and for four years, beginning in 1956, sang tenor with the CSD champion Four Cavaliers. They were good years. He loved to talk quartetting and barbershop and loved singing with the Heart of America Chorus. He attended nearly every District and International chorus contest.

Frazier Allen died at the Villa St. Joseph Rehabilitation Center in Overland Park, Oct. 26, 2011, after suffering a fall and a subsequent stroke that ended his many years as a barbershopper, and a lifetime of accomplishments. He will be missed by the Barbershop Society, the Kansas City Chapter and his many friends at *HOA*.♥



In his preservation research, Grady comes up with dozens of fascinating people and topics. He devoted a special issue to barbershoppers directly involved in the 9-11 attacks and aftermath. Another issue featured Society headquarters



The brothers issue goes into amazing detail about some 40 sets of brothers – from **Jim and Rob Henry** to two sets of **Wright** brothers (can you name them? Hint: the ones we know best are not in a quartet together). There are the **Slamkas** (and family), **Knudsens** (you might know them better as *Six*). And of course the **Halls** and **Schmitts**.

At last reading of our accounts, the Fund had less than a thousand dollars. That amount will not help very many in ways that could make a difference. Barbershoppers Discover Fountain of Youth!

Well, perhaps we didn't really discover it, but maybe we've been unknowingly partaking and benefitting from it. Now I'm going to let you in on a little-known study that may explain it. I hope you leak

it to others – especially prospective new members.

You see, we do lots of deep breathing, some dancing (very little), we employ an enormous amount of focus and brain function while learning and recalling music, we have to listen and interpret, and we give willingly of our time to many functions that benefit others.

This Fountain of Youth I speak of is called "Volunteering." Take a look at the article I was given some time ago at my weekly cardiac rehab class:

Volunteering — A Possible Prescription for Better Health!



Does volunteering make you healthier, or do healthier people volunteer? A report issued in April of 2010 by United Healthcare and Volunteer Match provides compelling evidence

that volunteering can enhance physical and mental health.

Among key findings:

- More than 68% of those who volunteered in the past year report that volunteering made them fee physically healthier.
- 29% of volunteers who suffer from a chronic condition say that volunteering has helped them manage their chronic illness.
- 89% of volunteers agreed that volunteering improved their sense of well being.
- 73% of volunteers feel that volunteering lowered their stress levels.
- 92% of volunteers agree that volunteering enriches their sense of purpose in life.
- More than three-quarters of volunteers who participate in service activities through work report that they feel better about their employer because of the employer's involvement in volunteer activities.

Other studies also have found the following potential health benefits, particularly for older adults:

- Improvement in cardiovascular health. Being a volunteer can lower your blood pressure and improve heart problems. A study from the University of Michigan Research Center showed that among individuals with a history of heart problems, those who volunteered had reduced chest pain and lower cholesterol levels.
- Lower risk of death. Another study on older adults who volunteer regularly demonstrated that those who spent time volunteering may enjoy a longer lifespan.
- Better mental functioning. Concerned about preserving your brain power? An increase in cognitive (mental) functioning is yet another potential benefit of volunteering.
- Overall mind and body improvement. Volunteers have been shown to have reduced anxiety and depression and an overall sense of well-being. Volunteers also have been found to recover more quickly from surgery, sleep better and have healthier immune systems compared to people who do not volunteer.

Volunteering may do more than make you "feel good:" it could turn out to be "good for you" as well!

So what do you think? Sure, we pay an annual membership fee for the privilege. Consider it the cost of organizing and maintaining some sense of order. Still it sounds like a lot of what we do, right? How many of you feel better when you leave a chapter meeting than before you got there? How about after a show or the Caroling Cara-



van? What about Singing Valentines? How many of you who volunteer in activities related to your employer feel better? What about your church activities? Perhaps more importantly, just the random event that hits you unexpectedly and you nail it!

I believe in this "fountain." I believe its' part of "the good life." I like it. I believe it's much of why I'm still here. ♥

One Look at District Chorus Competitions, 2011

As this is more than a month beyond the district competition, you know that *HOA* qualified for the international competition in Portland next July with an average score of 79.1 percent. What you may not be aware of is how lucky *HOA* was to qualify.

Our score was 24th-best among all Society choruses entered in the fall contests. And the chorus that placed 25th was a mere three points (17-hundredths of one percent) behind us. Our seed was the 10th and last available seed. However, six districts qualified a district champion for the 2012 International with a score lower than ours.

Overall, 29 choruses competed and qualified for International 2012. The average score was 81.5 and the average number of men on the risers was 51. A total of 291 choruses competed in 17 North American districts, British Isles and Sweden. I could not find scores for Australia, New Zealand or any of the other overseas affiliates.

At the top of the heap is *Ambassadors of Harmony* at 94.6. They will be challenged by *Great Northern Union*, who scored 93.7. No one else is close. The three bronze medals will be contested by *Kentucky Vocal Union*, *The Alliance* (Ohio), *Southern Gateway Chorus*, *Zero8* from Sweden and *Atlantic Vocal Project*, all of whom posted scores between 84 and 88. Four of the choruses that chose to sit out posted higher scores (over 88) in last year's district competitions.

Central States District continues to be one of the stronger districts in the Society, both in terms of number of choruses competing and average size of competing chorus. Nine districts and the BABS affiliate had at least 15 choruses competing (CSD had 16), CSD averaged over 40 men per

chorus, best of all districts, and the average performance level (68.7) was the best of all districts with at least 15 competing choruses, and third-best among all districts. RMD was number one, at 69.6 with 10 choruses. Overall, the average size of a competing chorus was 31 men and the average performance level was 65.7%.

With so many high-quality choruses on the sidelines this year, any attempt to measure the strength of the districts looking at the best five or ten choruses from each district needs to account for these quality choruses not competing this fall. Note that these choruses were included by selecting their district score in 2010. International scores were not considered in this analysis.

Looking at the best five, Central States averages 82.8, behind only Far Western District (with two reigning champions) at 85. Close behind are Mid-Atlantic (81.9), Southwestern (81.1), Johnny Appleseed (80.9), Land of Lakes (79.8) and Dixie (79.2). The average for the best five from each of the 19 districts was 76.7.

When the best 10 choruses from each district are considered, CSD (74.7) stands fifth behind Far Western (78.3), Mid-Atlantic (77.6), Dixie (75.6), and Johnny Appleseed (75.4). Last year, CSD was third in this group at 76.6, so the district average score declined nearly two percent from last year. The overall average over 19 districts for this group was 71.5, compared to 70.9 last year.

To HOA's good fortune, a few International Contest powerhouses like the *Denver Mile High Chorus*, *Tornoto Northern Lights* and the *Vocal Majority* decided to forego the contest next July in Portland. So *HOA* is going to the show, Life is good!
