

Are we succeeding with our membership goal? We have added







Todd recently took over the role as *Harmonotes* Editor succeeding **Dale Neuman**.


"I love my chapter and look forward to the day I can get back on the risers. In the mean time, it's a joy to serve HOA as Harmonotes editor." Todd says.

JIM BAGBY IS TOP BELLRINGER!

"Thirty years of service, one Saturday every year during the month of December, singing for a total of four hours for the Salvation Army. During that time, Jim has warmed up for 1 hour every year then followed that by a total of 3 hours singing, with a half hour of break in between each half our performance. Four hours singing per year times 30 years for a total of 120 hours singing. 10 songs per half hour equals eighty songs sung per year or 2400 songs total over 30 years. On average he has sung to 200 people per performance, so over 30 years that's an audience total of 36,000 people. His efforts have helped raise approximately \$45,000 over that 30 year span."

We believe Jim Bagby is truly deserving of this award and are proud as a chorus and as friends to be associated with a man of such generosity. We look forward to many more years of Bellringing with Jim by our sides.

Jim Bagby was contacted by a quartet at Raytown South High School who wanted to do the *Gas House Gang* version of "My Old Man's a Sailor." They were trying to take it off the GHG CD, and wondered how to reach the arranger to see if the music were available.



Ten Years Ago— June, 1990

David Krause, in an announcement at the end of our chapter meeting on May 22, informed those present of his intent to resign as HOA Musical Director effective July 1. David had held the job of HOA Chorus Director since November of 1987 when he replaced Steve Leone. He led us to second place finishes in CSD competition in 1988 and 1989. Taken by surprise by the unexpected announcement the chapter board had not been able to give thought to the selection

of a replacement. Happily, David did indicate his intent to continue as an active member of the chorus and his quartet *Special Touch*.

Twenty Years Ago-March, 1980

There was a new quartet announced called "The 12th Street Regulars" with **Rod Rule** (tenor), **Rich Huyck** (lead), **Jim Davis** (baritone) and **Kent McClean** (bass).

Musical director **Jim Bagby** announced the very first coaching session for our trip to International at Salt Lake City in July. Our coach would be **Darrell Flynn**, then International Sound Category Specialist, later Society President and currently our Society Executive Director.

In action by the chapter board **Ross Lankenau's** chapter membership was approved, **John Stucker** became the new cochairman of the riser committee and **Marvin Faulwell** was appointed to the chapter board replacing **Joe Costigan**.

Thirty years ago-March, 1970

May 15th was the occasion of the annual Ladies Night Dinner held at the Armour East Restaurant. The evenings' entertainment was provided by the HOA Chorus, *The Mid-Americhords*, *The Missouri Pewekes*, *The Kansas Citians* and a Sweet Adeline quartet *The Blenditions*. The BOTY award went **F. M. Davisson** (they called "F. M."). **Fred Whisman** was chairman of the special events committee. Good job, Fred!

Chapter President **Joe Costigan** announced that HOA along with the NOJOCO (now Overland Park) chapter would be making a bid for the 1974 International Convention.

LET'S DO IT AGAIN THIS FALL

Mark Oct. 3 on your calendar. That's the date of the next major HOA quartet competition, the annual **Bush League Contest**.

One big difference: no one is going to appoint your quartet. You can sing with whomever you like (providing no more than two of them have competed at the district level). (If they have sung at district, they have to sing a different part—see me for rules and exceptions).

While the Spring Fling is aimed at giving as many as possible some quartet exposure, the Bush League is designed to encourage formation of quartets. And instead of made-up judging rules for one song, Bush League foursomes will be judged by qualified judges in categories similar to those used in the C&J program.

So start looking now. And let me know if you need a part; I'll try to help.

A "REFRESHER" ON CHOREOGRAPHY

Since the membership committee has been doing such a great job with bringing in new singers, I thought maybe it was time to restate some basic visual positions and terms related to choreography.

PSP-(*Perfect Singing Position*) Outside foot slightly ahead of inside foot-middle finger placed approximately at the seam of pants-slight press toward the director with energy in your arms.

Box - Each of you have a box that you stand in on the risers, it's your space. It's used as the basis for describing a move or position such as weight shift to the outside back corner of your box etc.

Little X - Visual position through the director

■ Fig X - Visual position past the director to approximately the first few rows of the auditorium.

Super X - Visual position looking at the center of the back wall of the auditorium. *Note: When the director is facing the chorus your eyes are on him with only rare exceptions. When he turns to the audience your focus moves to super X.*

Stage Right or Left - Visual position looking at the left or right corner of the stage.

Super Right or Left - Visual position looking at the left or right back corner of the auditorium.

Down Stage - Toward the audience.

Up Stage - Toward the risers.

Early choreography practice will continue on a regular basis—*everyone is welcome!* ~

- Q. When will I find out what my committee assignments are?
- A. Committee assignments will be mailed out during the week of May 22 - May 27.
- Q. Will I be able to work on the committees that I reauested?
- A. Where possible, you are assigned to at least one of the committees you requested. However, you may be assigned to other area(s) that needed help.

Q. How did you make the committee assignments?

A. Here are the guidelines:

- (a) If you marked your available days or times as "No Pref" or you did not indicate a preference, you were assumed to be available all week and for any shift and assigned accordingly.
- (b) If you did not include information such as preferred work schedule or shirt size, that information was assumed. You will have time to make changes before the convention if it is wrong.
- (c) The first five preferred committees were used as your preferred committee assignments.

Q. How many shifts must I work to receive a convention shirt?

A. You must work two shifts in order to receive a convention shirt. In general these shifts are 4-1/2 hours in length.

Q. What are the shift times?

A. The shifts are as listed below. However, the start and end times may vary depending upon the event. You will be advised of the exact times either by letter from the Staffing office or your Committee team leader.

8:00am to 1:00pm Morning Afternoon 1:00pm to 6:00pm

6:00pm to 10:00pm or until event is over. Evening

Night 10:00pm to 2:00am
