bers we can be satisfied with. Aside from the numbers alone, I'll be happy to hear the sound that *HOA* has been making for MOST of our rehearsals of late; if that happens, and the performance has the energy and involvement we've discussed, let the results fall where they may. 

So, you're asking, "Why? What'd you old coots do that for, anyway? Those pipes are bad enough, and now you're going to rattle bamboo in our ears?" And we answer, "OK, we admit to the 'old coots' part. And as to the 'why,' lemme 'splain."

So, on the Holiday Spectacular, ancient *Tone-Henge* will be singing a new-to-us but ancient tune, accompanied by ancient angklungs.

## Chord Basics: Part I by Bruce Wenner



You may recall my 2005 series of articles titled "Barbershop in Fifths." Some of you expressed

your enjoyment of the articles, but others were unable to understand them because they lacked basic knowledge of chords and intervals. That inspired this article, in which we backtrack to look at the basics. If you already know the basics, the article is not for you. If you don't, please open your copy of *That Old Quartet Of Mine* before reading on —we will be referring to chords in OQ in what follows.

To understand chords, you just need to recognize two kinds of intervals. To do that, all you have to do is count "half steps." A half step is the interval between two adjacent piano keys, black and white. An octave of 12 half steps lines up like this, starting at C and going up from there:

C – C# - D – D# - E – F – F# - G – G# - A – A# - B – C

Okay, now we can look at the two important intervals in chord recognition, the major third and the minor third. The major third interval is the sum of four half steps, and you can use the diagram to count them. A major third starting at C is-well, the first half step is C to C#, the second is C#-D, the third is D-D# and finally D#-E - we ended on E, so the interval from C to E is a major third. Now start on E and add the four half steps. E-F, F-F#, F#-G, G-G# - this major third is E-G#. How about a major third starting on A? To count the last of the four half steps, add "-C#" to the right end of the diagram (that's fair-you can add as many notes as you want, using the left end as a guide); now we end on C#, so the major third is A-C#.

The minor third is even easier—it is the sum of only three half steps. C to D# is a minor third (and, since D# = E $\downarrow$ , so is C to E $\downarrow$ ). Similarly, we get E to G as a minor third, as well as A to C.

Now we are ready to look at the simplest of the chords, the triad. A triad is a chord consisting of three notes: (1) the starting point, called the root, (2) a note up a major third or minor third from the root, and (3) another note up a major third or minor third from the second note. Examples of C-triads (we name the chord by its root) are C-E-G, C-E\b-G, C-E\b-G\b and C-E-G\#. An example of a G-triad is the first chord of OQ, on "Sit-"—the three notes in the chord are G (in both the bass and bari), the lead's B (up a major third from B).

This chord is an example of a special class of triad, the major triad. A major triad is built from the root by a major third, then a minor third, so the long name for this chord is "major-minor triad"; we barbershoppers shorten it to "major triad" or simply "major" (chord) - these terms all refer to the same kind of chord. In our example from OQ, the triad is built from the root (G) by a major third (to B), then by a minor third from B to D. So it's a G-major triad. or a G-major chord, or (even more briefly) simply a G-chord. This triad has a bright, joyous, very consonant sound to it, with no hint of tension. The physicists will tell us the reason-the harmonics, or overtones, reinforce each other well within our hearing level and they do not clash.

The next most important triad is the minor triad, or the "minor-major triad." This one is built up from the root by a minor third, followed by a major third. In measure 3 of OQ we have E-minor triads, or E-minor chords – from

the E root to the lead's G is a minor third, followed by a major third to the bari's B. Only three notes in this chord, since the bass and tenor are both on E, the root. [Aside: this is the voicing we will usually see in a three-note chord sung by four parts - two parts sing the root. The E-minor chord keeps coming back in OQ (on "-tet" in meas. 14, "hope" and "pray" in meas. 22, for example), and each time the root is doubled. This voicing is also used for major triads-in our example from measure 1, the bass and bari double on the root G.] The minor triad has a different feel to it, darker than the major, with a melancholy tinge. This time the overtones do not reinforce each other nearly as well as they do in the major chord.

There are two other ways to build triads. The minor-minor construction is called the diminished triad. In barbershop harmony, this triad is rarely sung without a fourth note, which tends to be a flatted or double-flatted seventh. In the first case, we call the chord a half-diminished seventh – the other is called a fullydiminished seventh. More about these chords next month. For now we will find a couple diminished triads within diminished-type chords in OQ. Want to look for the first one before reading on? (*Warning:* that's a trick question).

The first one is on "and" in measure 6. The root is the bari's E, then a minor third to the lead's G, then another minor third to the bass's B<sup>1</sup>. The fourth note (the D in the tenor) is a flatted seventh up from the root E, so this chord is an E-half-diminished seventh. The next diminished chord is on "of" in measure 7; each of these notes is a minor third above another, so it is a fully-diminished seventh (if you hear the term "diminished chord", this is the kind of chord that's being cited).



"Wait", I hear you say. "I found one earlier-first chord of measure 2." Yes, there is a diminished triad in there (D#-F#-A), but the chord is not built on the D#—it's actually a barbershop seventh rooted on B! More about that next month. For now, we will simply leave it at this-if a chord does have a major or minor triad in it, that triad will name the chord, even if it also contains a diminished triad; the strong triad takes over from the dissonant diminished triad when we hear it.

The last of the triads is built on two major triads—we call this the augmented triad. This triad is rare in our music and when it appears it comes as a complete chord, called the augmented chord. In OQ we have to scan all the way to "Just" in measure 52 to find one: the root E is doubled (bass and bari), up a major third to the tenor G#, and up another major third to the lead C. We hear a kind of open, hollow quality to this one, right?

"Wait" again. "You called this Chord Basics-isn't the barbershop seventh one of our basic chords-and you haven't even gotten to that one." Well, we're just about there. Tune in next month for Part II—that is, if you've read this far. ♥

So we've had a tremendous list of visitors and gained two new members. I would say September was a good month. Keep those guests coming, gentlemen! ♥









### TEN YEARS AGO: SEPTEMBER, 1997

Not having a September 1997 issue of *Harmonotes* to search for news for this segment, I peeked into the Oct. 1997 edition to see if I could find

something there. Once again, as has happened numerous times since I've been an *HOA* member, the contents of that issue were overwhelmingly indicative of what can be expected of a large, active, highly motivated and well-managed chapter.

Right there on the front page was an item by **Mike Neff**, who was co-chairman for *HOA*, announcing the coming of the "Holiday Harmony Spectacular," the very first collaborative Christmas show with the Kansas City Sweet Adelines to be held on Dec. 6 at the RLDS Auditorium in Independence. This performance has been an annual presentation ever since.

Then **Don Peck** filed a story about the great success of the fourth annual *HOA* retreat at the Mount Conference Center in Atchison, Kansas, on Sept. 12-14. The coaches were **Marty Lovick**, a Presentation judge and a member of the Harmony College faculty, and former *HOA* member, **Don Kahl**, also a former *HOA* member, at that time a four-time gold medalist (with the *Vocal Majority*) and tenor with the international champion *Rural Route 4*.

And that's not all! There's an account of a trip by the *HOA* chorus to Manhattan, Kansas, to be part of the show scheduled after the first CSD Southwest Division preliminary quartet contest. Seventy-four singers piled into two buses for the trip. Author **Don Peck** explains, "By all accounts, this very first quartet preliminary in the new format was a success." Did I miss something? Wasn't the division organization of the district discontinued some time before

this event took place? Apparently it wasn't considered that much of a success because the system is no longer used.

And, oh, yes, even our beloved "Heartbeats" were busy planning for their ninth annual Christmas Party/meeting/auction at St. Peter's church of Christ on December 9. Wives, daughters, mothers and friends were invited.

But not all the news was good news. Away back on page 13, in less than half a column, **Dale Neuman** reports on something probably nobody else wanted to write about—the third-place finish by *HOA* at the district contest earlier in the month. To my recollection, it was the only time that a **Bagby**-directed *HOA* chorus ever placed lower than second place. But it was close; the "Barberboys" of St. Joseph beat them by only nine points.

### **TWENTY YEARS AGO: SEPTEMBER, 1987**

You know, I don't ever remember this one. *The Heart of America Chorus*—my chorus—was booked for a show at the Granada Theater in Kansas City, Kansas, on Sept. 12. The theme was "Quartets...and All that Jazz," with the *New Red Onion Jazz Babies*, the *Rural Route 4*, the *Jubilee Transfer, Just Friends* and "**Dr. Marvin Faulwell** at the Magnificent Grand Barton Organ." I couldn't have forgotten it, because I put a bill that occupied an entire page in MY bulletin! Did anybody see me there? I'll cry myself to sleep tonight.

### FORTY YEARS AGO: SEPTEMBER, 1967

On the last page, away down in the lower right-hand corner, almost forgotten, is a small announcement of the passing of **Edgar E. Schlieb** on Aug. 17. Eddie was a member of the Kansas City chapter for 27 years, during which he founded the *Gamboliers* and sang lead with that quartet for many years. ♥

## Flare Man by Carl Turlin, Program Vice-President



know it's a weird title and I'll explain it in a minute. Meanwhile, about this PVP thing, I just couldn't find a concise job description, even in the Society policies, so I asked Jim Bagby, Don Young and Jerry Garrard. You'd think those Barbershop

cheerleaders would know, wouldn't ya?! Well, come to find out that it's basically a job description by committee, that committee being the board and the music team of the chapter in which you're a member. With that kind of ambiguity as a foundation, I attended COTS with Dick Korek, Doug Brott and Kevin Tritsch, hungry for information about my responsibilities.

On a biting cold Jan. 13 this year, we journeyed to St. Joseph where I attended a COTS class entitled, "Chapter Development," instructed by the dedicated and slightly goofy, but always energetic, Bob Cox (a former Evergreen District president). Through his stories, his Powerpoint presentation and our stories and questions, I began to see the framework of the PVP job through the snowy mist.

Those responsibilities include ensuring that the rehearsals run according to the schedule (more on this later), constructing, copying and distributing the In-Tune, with input from the director and members who have announcements, attending music team meetings and board meetings (and performing liaison between the two when appropriate), promoting quartet singing and singing skills, and being available for activities that chapter leaders are generally expected to help with.

Developing programs to support singing skills and quartet singing can include activities that involve focused training and fun, such as our "Potluck, Practice and Pool." Supporting the chorus by fundraising isn't out of the question and can include activities like the golf scramble or a walk-a-thon. I'm particularly interested in the educational aspect of singing, so our program committee is looking at ways to get the most out of our in-house coaching buck.

One of the most consistent and challenging aspects of the PVP job has been trying to run the rehearsals according to that night's schedule. The various directors get on a roll and sometimes they don't see my signals that their time is nearly over for their allotted time slot on the warmups or a song. Even though I sometimes stick my arm out with the remaining minutes, put my hand against my chest with the minutes left, mouth the minutes, wave my hands, all in an effort to not distract everybody on the risers from the director, each night continues to be a challenge in this area. So, I'm changing tactics.

Henceforth, I shall not be called the PVP, I shall be called FLARE MAN! I will hold out a safety flare when their time is nearly up! (Pay no attention to the man with the flare!) I will decide on the spot whether I will ignite the flare, but don't worry, just keep on singing, like nothing happened, ok? With that, the rehearsal will continue, on schedule, with the next director calmly clipping the little microphone onto his shirt and we'll sing the next song, and everybody's happy, right?

Sounds good to me! ♥

After we talked at some length, he indicated that the idea of the endowment fund seemed closest to his hope because it would be an on-going rather than a one-time thing. This led me to reflect that maybe more of us would like to think along those same lines when we make our next donation or re-visit our wills and estate plans.  $\heartsuit$

Quinton received his bachelor of science and master's degrees from the University of Missouri-Kansas City and his doctor's degree in mechanical and aerospace engineering from the Delft University of Technology, Delft, the Netherlands.

Before his retirement, Quinton was associate dean of the Coordinated Engineering Programs at the University of Missouri-Kansas City, as well as professor of mechanical engineering. He had been recognized by NASA and wrote numerous papers.

A big round of thanfrom G, especially from his wife, **Peggy Bowles**, and daughter **Lisa** and the rest of Quinton's family, and also from those of us in *Cardio Jam*, **Jim Bagby's** non-barbershop mini-chorus at the St. Luke's Rehab Facility, is due the *HOA* group who responded on short notice to sing at Quinton's Monday morning service on Aug. 27.

It was pretty easy to get to know Quinton and become his friend. A few of you may remember him from *HOA* in the '60s and early '70s as a member who loved barbershop. Although he worked out at St. Luke's South, he drove from Overland Park to the Plaza to practice and perform with *Cardio Jam* at our Christmas party and summer picnics. One day he even produced an old beat-up tape (not a CD) of the *Rural Route 4* to show us. He attended *HOA* performances and send-offs when he could.

He was very laid back, enjoyed a good story and, as one of our *Cardio Jam* members said, "He could roll those big eyes like no one else to make a point, or to be just an ornery old curmudgeon."

His doctoral dissertation was titled, "The Role of Environment, Frequency and Wave Shape During Fatigue Crack Growth in Aluminum Alloys," which he dedicated to his family. It was also reported that he recently framed and presented to his wife, "Peg o' My Heart."

The celebration of his life service began with **Dean Martin's** "Memories are made of This," and closed with **Harry Connick**, **Jr.'s** "A Wink and a Smile." The following *HOA* members sang the BHS arrangement of "I Believe," with **Carter Combs** capably subbing for Jim, who was out of town. ♥
