HOA Board of Directors Minutes: May 13, 2019

- 1. Call to order: unsure, probably 6:05.
- 2. Motion to approve minutes of Apr 8, 2019 was made and motion passed.
- 3. Treasurers Reports on file, data presented by Harvey Shapiro.
  - Summary: Total funds in the cash account amounted to \$18,454.08. Included in this amount was \$8,388.43 in the Truman fund (restricted). This amount included \$3,079.51 set aside for the purchase of sound equipment, and \$5,308.92 for the Dexter scholarship fund designated to be used to pay for a Harmony University registration. Total unrestricted funds were \$10,065.65, compared to the prior year which was \$10,308.88. The month of April reflected a loss of \$2,981.49 and a Year to Date loss of \$1,540.64. The budget numbers were adjusted in April to reflect 2019 numbers, except no adjustments has been made for the 2019 Holiday Show.
- 4. VP Reports
  - a. Marketing/PR:

The ad for the program at the New Theatre for "Joseph and the Amazing Technicolor Dreamcoat" is being designed by Adam now.

- b. Membership: Don Fuson (report attached).
- c. Music Team (report from Bob Velazquez attached): We are still without a VP/Music. We discussed making some more public appearances, e.g. in a park. Mackin (sp?) Park in NKC was mentioned.
- d. Operations: Steve Keisker: No report. All of our stuff is out of South Broadland. We discussed the trailer.
- e. Program: Jerry Meier (report on file and attached) There will be no director on 5/21 and we'll have a rehearsal with fun and refreshments.
- 5. Event Reports
